

## **76®/JACKSONVILLE JUMBO SHRIMP 2019 TICKET PROMOTION OFFICIAL RULES**

### **OPEN TO UNITED STATES RESIDENTS OF FLORIDA, 18 YEARS OF AGE AND OLDER ONLY**

#### **PROMOTION:**

The 76®/Jacksonville Jumbo Shrimp Ticket Promotion (the "Promotion") is sponsored by Motiva Enterprises LLC. "Motiva" and Jacksonville Jumbo Shrimp (the "Jumbo Shrimp"; hereinafter, the Jumbo Shrimp and Motiva shall be referred to individually and collectively as the "Sponsors"). During the Promotion Period, purchase a minimum of eight (8) gallons of fuel at a participating Jacksonville 76® gas station to receive a voucher valid for two (2) general admission tickets to one (1) eligible Jumbo Shrimp home game during the 2019 regular season. 76® is a registered trademark owned by Phillips 66 Company ("Phillips 66 Company") and licensed for use by Motiva.

**PROMOTION PERIOD:** July 17 – August 23, 2019, while supplies last.

#### **HOW TO PARTICIPATE:**

- To receive an official Jumbo Shrimp Ticket Voucher at a participating location, fill up with a minimum eight (8) gallons of any grade fuel at a participating 76® gas station between July 17 – August 23, 2019, or while supplies last.
- At the time of purchase, request a Ticket Voucher from the cashier or attendant. Limit one (1) Ticket Voucher per customer, per visit. Each voucher is valid for two (2) general admission tickets to one (1) eligible Jumbo Shrimp home game during the 2019 regular season, subject to ticket availability. A maximum of 5,000 tickets will be given away. All transactions in connection with the Promotion must be completed online at the Website, by Phone or in person at Baseball Grounds of Jacksonville, 301 A. Jumbo Shrimp will determine the available seat locations at its sole discretion.
