

Grow The Game Promotion

Eligibility

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO PARTICIPATE. This promotion ("Promotion") is open only to individuals ("Entrants") who are legal residents of the state of Oklahoma that are 18 years or older. TerraScapes (the "Sponsor"), the Oklahoma City Dodgers ("Dodgers"), advertising, promotion and fulfillment agencies and each of their respective parents, subsidiaries, affiliates, employees, officers, directors, and members of the immediate family or household of each of the above are not eligible to participate. This Promotion is offered only in Oklahoma and is subject to applicable federal and state laws. NO PURCHASE NECESSARY. VOID WHERE PROHIBITED BY LAW.

Participation/Promotion Period

To enter, completely fill out the entry form accompanied with at least one (1) piece of sporting equipment and drop the completed entry form and the equipment at the designated locations from May 17, 2018 until 6:00 p.m. CST on July 9, 2018. (the "Promotional Period"). Only one entry per individual; multiple entries and/or donations will not increase the chance to win.

Transportation

Sponsor will provide a round-trip ticket for each guest departing Will Rogers World Airport (arriving at Los Angeles International Airport) on Friday, September 21, 2018 and returning on Sunday, September 23, 2018. The Dodgers will contact the Prize winner to coordinate travel arrangements for all guests. Dodgers will only provide transportation between Oklahoma City and Los Angeles. It is the sole responsibility of the Prize winner to find transportation to and from airport, hotel and Dodger Stadium. All travel and accommodations will be selected and booked in the sole discretion of the Dodgers and the Sponsor.

Winner

Within one week from the end of Promotional Period, a winner will be selected at random from among all eligible entries received in accordance with these rules.

The winner will be notified by social media after the drawing. If the potential winner cannot be reached or does not respond within seventy-two (72) hours of the first notification attempt, is found to be ineligible, or declines to accept the Prize, the potential winner may be disqualified at Sponsor's sole discretion, and in such case, Sponsor will select an alternate winner from remaining eligible entries.
